

# Precautionary measures to be applied at Indoor and outdoor entertainment and game centers to mitigate the spread of Coronavirus (COVID-19)

**Entry** shall be restricted to:



**Those** who received the COVID-19 vaccine or recovered from the virus.



**Children** under the age of eighteen provided that children under the age of twelve are accompanied by a vaccinated or recovered adult.



**Evidence** must be presented via the (BeAware Bahrain) application, any other approved application, or by presenting official documents providing proof of vaccination or recovery.



**Organising** visits must be via prior registration or electronic reservation whenever possible in order to reduce crowding.



**Separate** entrances and exits must be allocated if possible. Ushers should be appointed at the doors to ensure that visitors follow the proper entry/exit procedure, prevent crowding, and ensure social distancing.



**Clear** signs must be placed to ensure social distancing of at least two meters in waiting areas, entrances, ticket sales points, food and beverage venues, restrooms.



**The temperatures** of all the facility's workers and customers must be measured before entering the facility using an infrared thermometer. People with temperatures of 37.5 C or above, or those exhibiting COVID-19 related symptoms, should be prohibited from entering, asked to leave immediately and call 444.

# Precautionary measures to be applied at Indoor and outdoor entertainment and game centers to mitigate the spread of Coronavirus (COVID-19)



**Customers** over 6 years old must wear a mask at all times (except for activities that require physical effort).



**All employees** must wear masks at all times.



**The facilities'** capacity should be reduced to no more than 50% to ensure that social distancing is maintained.



**Seating** should be rearranged to maintain social distancing of at least 2 meters.



**Adequate supplies** of personal hygiene items such as soap, hand sanitisers with a minimum of 70% alcohol, tissue paper, and rubbish/garbage containers which open without touching should be provided.



**Frequently** touched surfaces should be cleaned and disinfected with alcohol sanitisers. This includes: climbing and playing handles, chairs and tabletops, door handles, toilet surfaces, and handwashing areas.



**Toilets** must be cleaned and disinfected periodically, preferably every two hours, while ensuring good ventilation and lowering the temperatures in them.



**Supervisors** should be appointed to reduce gatherings between different groups and adhere to social distancing, provided that there is a distance of at least two meters between families.

All recreational facilities and shops shall be subject to inspections by the relevant government agencies to ensure compliance with health requirements.



Customers must be encouraged to pay online and via contactless methods.



Employees must be encouraged to get vaccinated.



Rides or games that are difficult to sanitize should remain closed.



Any facility that does not comply with the requirements stipulated here, or any other related guidelines, shall be closed.
